ABOUT US

FORM Dance Projects is a unique, innovative cultural service provider that aims to foster and develop contemporary dance culture in western Sydney. FORM Dance Projects delivers a vibrant, engaging dance-based artistic program creating professional development opportunities for emerging to established choreographers and dancers. FORM provides access to dance education, appreciation and participation opportunities for the western Sydney community.

Since its inception in 2001, as Western Sydney Dance Action, the organisation has established strong networks with Local and State Government, education and community-based sectors, and has a Board comprised of representatives from government, business and the arts.

FORM Dance Projects has matured from a small dance service provider into a professional arts organisation with a growing reputation for presenting a high calibre artistic program of contemporary dance works. FORM has delivered projects in partnership with high profile arts organisations such as Sydney Festival and the Australian Chamber Orchestra.

FORM presents a curated multi-stranded dance program across the four key areas of presentation, education, professional development and community outreach. FORM creates, shapes and forms a diverse program of dance projects in collaboration with choreographers, dancers and artists.

These projects are presented throughout the year in a signature season, Dance Bites, or special events, creative development projects, education workshops, masterclasses and programs such as Fast+Fresh Dance. A key driver for FORM is facilitating professional development for western Sydney choreographers and dancers. The emergence of new dancers via pathways provided by education, mentoring and auspicing programs is testimony to a growing degree of success.

FORM maintains strong community partnerships through links with key service providers such as STARTTS, the NSW Service for the Treatment and Rehabilitation of Torture and Trauma Survivors. FORM auspices CPAN, the Cultural Performing Arts Network, representing over 500 community cultural performers in western Sydney.

MESSAGE FROM THE CHAIR

2013 was a terrific year of change for FORM Dance and enormous thanks must go to the staff led admirably by Annette McLernon. Annette was joined this year by Sally Ebert as Business Manager and supported by the dedication of talented staff including Carl Sciberras and Tanya Veselcic. The change of location to new offices and studios at Connect initiated a new era consolidating FORM as the western Sydney place for the creative development of dance.

Partnerships resulted in an outstanding and diverse Dance Bites 2013 season. In 2013 this has been especially successful with the engagement of young people, students and teachers through the Learn the Repertoire, See the Show and Fast+Fresh Dance programs. The participants in these programs, and also our adjunct Cultural Performing Arts Network (CPAN), are able to explore the many intangible elements of social engagement and share in the possibilities of contemporary dance through cross-genre collaborations and community cultural exchange.

We are continually grateful for the ongoing funding support provided by Arts NSW and will work diligently to achieve our joint objectives.

Also thank you to Robert Love and the staff at Riverside Theatres who are a vital partnership and provide FORM with the many resources to do what we do.

As Chair congratulations must also go to the Board who I am proud to work alongside. The Board members are energised by the planning for positive outcomes in the coming years to ensure a sustainable future for FORM as an anchor for dance in western Sydney.

PROGRAM OVERVIEW 2013

The year seemed to go by at lightning speed so much has happened at FORM. The organisation has successfully established itself as a creative hub for contemporary dance in Parramatta, NSW.

A major highlight was the premiere presentation of the Dance Makers Collective, *Big Dance In Small Chunks*, in the October Dance Bites program. This launched the new collective of ten NSW based early career dance makers and artists who with determination and initiative have navigated their way through the constricted landscape of what the sector has to offer emerging tertiary trained dance artists. DMC has garnered significant industry support along the way not only from FORM Dance Projects but in addition from Ausdance NSW, Sydney Dance Company, Legs On The Wall, Bundanon Trust and funding from Arts NSW and Ars Musica Australis. They have definitely made their mark and represent the next generation of young contemporary dance artists forging their way on their own terms. Jill Sykes credited DMC's premiere of *Big Dance In Small Chunks* as the "Most Significant Dance Event in 2013" - Dance Australia Magazine.

Another highlight of the Dance Bites 2013 program was *The Tap Pack*. A group of commercial professional artists, triple threats with a passion for tap dance and a track record in musical theatre and feature films, came to FORM with the desire to produce their own show. The short season presented by FORM on the Riverside stage was one of the most successful Dance Bites presentations to date. FORM assisted the Tap Pack to pitch their work at The Long Paddock in 2013 and the Tap Pack have gone on to secure further presentations with interstate venues in 2015.

It was a pleasure for FORM to present Martin del Amo's Little Black Dress Suite - a perfect

opportunity to see the "suite" of solos performed by an impeccable cast of independent contemporary artists including Sue Healey, Kristina Chan, Miranda Wheen and Martin del Amo. *Lineage* was a cultural gem in the Dance Bites program – an exploration of traditional and contemporary dance presented in a Triple Bill by Aruna Ganhimathinathan and Shruti Ghosh featuring Indian classical forms of Bharatanatyam and Kathak in *Nritya Roopa*, and recent NAISDA graduate, Thomas E.S. Kelly's *Dark Dream* and Tammi Gissell's *A Dip for Narcissus*.

FORM's Blogger in Residence project commissioned Vicki Van Hout to follow all things dance during her peregrinations throughout the year in Australia and Europe. The blog has a large dedicated following and contributes reputable critical discourse around contemporary dance to the sector. The blog also contributes significantly to the growth of FORM's online audience that is developing at a formidable rate.

This year's Fast+Fresh Dance competition for aspiring choreographers and dancers 21-and-under saw an increase in young culturally diverse participants from western Sydney. It was moving to watch the solo works of Abuzar Abdelrahim and Susan Abau, with the judges noting the gravitas they brought to their performances. Abuzar Abdelrahim was awarded with Best Male Dancer, an astonishing achievement for a young person starting to emerge in dance. Kei Ishii graduated from his last year in the competition, having reached the age of 21, taking two awards for his work A Memory including Most Outstanding Choreography and Best Group. This competition continues to provide the opportunity for these young talented western Sydney performers to hone their performance skills, receive critical feedback and network with industry professionals.

This year produced two creative developments of *PUNCTURE*, the cross-disciplinary project co-produced by FORM, Legs On The Wall and VOX, Sydney Philharmonia Choirs. *PUNCTURE* explores the rituals of courtship and social dance from masques, the court dances of Louis XIV to the moshpit. The initial creative development saw the key artists collaborating in a residency at Bundanon in February where ideas of social dance were explored, followed by an intensive three week development with the 12 dancers, including ten FORM mentees, included at the Red Box in Lilyfield. This was followed in October/November by a second four week development at the Red Box and the successful funding for a premiere presentation in Parramatta secured from Arts NSW and Australia Council for the Arts. Many thanks to the artists and funding bodies who have contributed to this project including Parramatta City Council, Bundanon Trust and Ars Musica Australis.

This year saw the start of a promising three year partnership with Sydney Dance Company to present the popular annual *Choreographic Workshop*. This intensive workshop introduces HSC Dance students, from western Sydney Secondary Schools, to the fundamentals of choreography and an overview of the choreographic style of Rafael Bonachela. This is an aspirational education program and provides students with a rare and valuable glimpse into the world of a professional dance company and a chance to the meet the artists and discuss their dance practice.

FORM has transformed into a busy and dynamic hub for the dance community. It has demonstrated its potential to deliver an artistic program of excellence, presenting contemporary dance to the highest capacity, and maximising opportunities for independent contemporary dance artists. Thanks to the ongoing program funding from Arts NSW, the valuable partnership with Riverside, the dedicated staff, the committed board and the passionate artists that enable FORM to make things happen!

Annette McLernon comes to FORM Dance Projects as an experienced arts manager, having worked for many leading arts organisations and festivals in Australia. Annette has worked as Film Program Manager for Perth International Arts Festival (WA) and Program Manager for Bundanon Trust (NSW). At Bundanon Trust, Annette was responsible for curating and managing the multi-disciplinary artist in residence program, and the public event program featuring many of Australia's leading artists, musicians and performers.

Annette has a Master of Arts in Film and TV from the Australian Film Television and Radio School, 1999 and has worked on many short films, dance films, documentaries and animations in Australia and Europe.

Program & Marketing Coordinator - Tanya Veselcic

Tanya is a graduate of Macquarie University's Bachelor of Creative Arts (International Studies) degree in dance, drama and performance. Alongside FORM she is an administrative employee at Actors Centre Australia and has previously worked on Front of House at Brent Street Studios. Tanya was a marketing amabassador for Sydney Morning Herald and held the position of Vice President on Macquarie Musical Society's Executive Committee in 2010. Interning at Irondale Theatre Company in New York City and on the Australian Youth Dance Festival 2012 with Ausdance NSW have been highlights of Tanya's growing career in the arts. She enjoyed assisting with the marketing of Spring Dance 2012 with Sydney Opera House and was a Programming Assistant for the 2012 Sydney Christmas program with the City of Sydney Events team.

Business Manager - Sally Ebert

Sally has over 15 years experience working in arts management. For the last two years she was General Manager for Legs On The Wall, Sydney and prior to that she was General Manager for Liz Roche Company (formerly Rex Levitates Dance Company) based in Dublin, Ireland. She also previously held the position of General Manager of the Kilkenny Arts Festival, Ireland and worked for the St Patrick's Festival, Ireland.

Education Coordinator - Carl Sciberras

Carl Sciberras is an independent producer and dance artist from western Sydney. Carl has a Bachelor of Arts (Dance) and a Bachelor of Arts in Communications (Writing and Cultural Studies) from the Western Australian Academy of Performing Arts and the University of Technology Sydney respectively. He is a core founder of two NSW based artist collectives – Flatline, a visual art and dance collaboration, and Dance Makers Collective, a collective of ten emerging dance makers.

Carl was the producer of Dance Makers Collective's *Big Dance in Small Chunks* (2013), Project Manager of *Fast+Fresh Dance* (2012, 2013), is the Co-Artistic Director of the ACPE Dance Company, works as an administrative assistant at Ars Musica Australis and was intern at Ausdance NSW, playing an integral role in the development of the *Bridge Dance* program. Carl is also an independent choreographer, having created works for the Home Brew Festival and Sydney Fringe Festival in 2012.

MARKETING

FORM initiated a rebrand and a digital strategy in 2011 which continues to deliver excellent results each year, expanding the organisation's reach nationally and internationally, and promoting our artists and program to a wide and diverse audience.

Alphabet Studios is a valued partner working with FORM to create an innovative brand and design for the contemporary dance works FORM presents. FORM also works with a number of respected photographers including Heidrun Löhr, Prudence Upton and Maylei Hunt, capturing definitive images of the artists and their works. This year FORM also commissioned Samuel James to create short videos of the Dance Bites works for a dedicated FORM Dance Projects youtube channel.

AUDIENCE DEVELOPMENT

FORM contributes significantly to developing new audiences for contemporary dance in Australia. The online audience has doubled in traffic since 2012 and receives 871,689 hits and 82,015 visits annually. The online audience is primarily within Australia but also reaches globally to the USA. China, Canada, UK, Netherlands, Finland, Japan and India. The increase in traffic is directly linked to increased engagement on social media and e-news platforms.

The Blogger in Residence project was launched in 2012 with the intention of contributing reputable critical discourse on contemporary dance. Since then the FORM blog has become a signature feature of FORM's digital strategy commissioning Vicki Van Hout, respected indigenous choreographer in 2012-2013. Van Hout's blog in February 2013 generated 35,000 views.

FORM takes pride in collaborating with artists in the dance community to present contemporary dance to this ever growing audience.

PROFESSIONAL DEVELOPMENT

FORM Dance Projects auspices and co-produces projects with creative development residencies and performance opportunities for professional artists. FORM also provides mentoring opportunities and the development of professional skills for western Sydney emerging performers through programming dance projects with performance based outcomes.

AAKASH ODEDRA MASTERCLASS

3 October 2013

In 2013, FORM partnered with Parramasala to deliver a unique masterclass with internationally renowned contemporary Indian dancer Aakash Odedra. Trained in the classical Indian dance styles of Kathak and Bharatanatyam in India and the UK, Aakash Odedra is a rising star of British dance. In 2011, Odedra worked with renowned choreographers Sidi Larbi Cherkaoui, Russell Malpihant and Akram Khan to create three sensational dance solos. *Rising* is the culmination of this, an evening of dance performed by Odedra, which also includes a piece of Odedra's own creation.

MASTERCLASS

This Masterclass was for professional dancers. Aakash facilitated a workshop which explored his choreographic style, which draws on his background in the classical Indian dance disciplines while remaining intrinsically contemporary in style. The workshop was dynamic and required a high level of skill and commitment from the participants, who were exposed to difficult and intricate choreography and physical training. Aakash discussed the importance of intent in the creative process which many participants found inspiring and transformative.

FORM Dance Projects, Legs On The Wall and VOX, Sydney Philharmonia Choirs' youth choir (aged 16-26), are collaborating on a cross-disciplinary project, PUNCTURE, which has been in development throughout 2013 to be presented in early 2015.


PUNCTURE uses a score drawn from the history of western song from Monteverdi to Radiohead to explore the rituals of courtship and young love. PUNCTURE is set in the present, at a party, a gathering where young people explore the various nuances of social discourse. The preening, the social groupings, the entrances and exits, the dances, the etiquette of flirting. The sound track of the party is provided by the 40 voices of VOX choir singing songs about love penned by some of the great composers from the history of song. Reimagining forms the core of *PUNCTURE*. As with the music, the choreography's starting point will be dances from history that have been created to bring people together in public, from masques, the court dances of Louis XIV, the various modes of ballroom, popular dances of the 20th century and the unbridled energy of the mosh pit. Ultimately, the experience for the audience will be like watching a party unfold where the physical language of the world tells a story that traverses time, revealing our deep connection and immense differences with what has gone before.

BLOG RESIDENCY

VICKI VAN HOUT

FORM Dance Projects commissioned Vicki Van Hout in 2013 to be the resident blogger after the success of her 2012 blog residency. Throughout the year Van Hout blogged for FORM about all things dance from her unique perspective as an indigenous choreographer. Van Hout has a dedicated and large following in her second year of the blog (up to 35,000 views of an individual blog). Van Hout's blog contributes valuable reputable discourse within the dance community and is a perceptive, entertaining and articulate window to the dance world for a larger audience. Some of her more memorable comments are below.

"The leap from a 10 minute idea to a 20, 30 or 50 minute product is huge. Without ongoing access to bodies or resources how does one make that leap? Like an everyday practice to fine tune the body, a choreographer only really comes into their own through practice and constant development, evaluation and redevelopment. For that reason I hope that this initiative has tangible support into the future." (Big Dance in Small Chunks, 30 Oct 2013)

"What unfolded before me was an amazing diversity of expression, representing a range of genres from tap to hip hop and cultures spanning the globe. The strength of each piece as wide-ranging as the experiences epitomised from teenage angst to immense cultural hardship and significance. Some dancers possessed a physical virtuosity beyond their years while others the ability to convey the gravity of profound emotion." (Fast+Fresh Dance, 19 Nov 2013)

"The last dances represented were those of now. The rowdy crowds in immense numbers. strangers' bodies squashed together. Touching no longer a gentle caress but an act of excited volatility.

This too brought memories from my teens, of pogoing to John Lydon of Public Image formerly Johnny Rotten The Sex Pistols at the Hodern Pavillion and to other bands with names like 9 Pound Hammer and Iron Prostate at various punk picnics. Still 20 years on and we are crowd surfing in huge numbers across stadiums, getting soused and sunburned simultaneously enjoying our big day out at any one of the major music marathon festivals touring the globe. The promising future of this work is its ability to access a wide range of kinesthetic experiences and for the audiences to connect in this way too. Proof that dance is still a dominant social lubricant."



Vicki Van Hout is a Wiradjuri descendant. She took part as an actor in the first aboriginal playwright's conference in Canberra before becoming a graduate of NAISDA Dance College and the Martha Graham School of Contemporary Dance NYC (graduated 1993). She returned to Australia to perform with Bangarra Dance Theatre the groundbreaking ballet, Ochres and The Edge Of The Sacred, in collaboration with the Sydney Symphony and The Aboriginal/Islander Dance Theatre. Vicki danced in Marilyn Miller's Dear Carrie (One Extra) joining Miller's Fresh Dancers, a highlight of which was a residency in Innsbruck, Austria and at the Adelaide Fringe in Marilyn's Quinkin (2004). Wirad'journi was Vicki's first full-length work, inspired by Wiradjuri kinship laws. She has choreographed for ATYP, Pulse8, NAISDA, WAAPA, the Helpmann Awards, and Quantum Leap. Her most unforgettable performance was as dancer/choreographer for the historic opening of parliament in lead up to the Apology.

I. SUMMARY OF ACCOUNTING POLICIES

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act NSW, 2009 and the Funding Bodies. The Committee Members have determined that the Association is not a reporting entity.

The financial statements are prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

(a) Revenue and Other Income

Grant and donations income is recognised when the entity obtains control over the funds which is generally at the time of receipt.

Interest revenue is recognised as revenue when received.

If conditions are attached to a grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of Goods and Services Tax (GST).

(b) Cash & Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at-call with banks and other short term highly liquid investments with original maturities of three months or less..

(c) Goods and Services Tax (GST)

The Association is registered for GST. Revenues, expenses and assets are exclusive of the amount of GST.

(d) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax under Div 50 of the Income Tax Assessment Act (1997).

(e) Employee Benefits

Provision is made for the liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(f) Plant and Equipment (PPE)

Office equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

(g) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(h) Comparative Figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

(i) Economic Dependence

The Association is dependent on grants from various Federal, State and Local Government bodies, interest income and charitable donations for the majority of its revenue used for its operations. At the date of this report the Committee has no reason to believe these bodies will not continue to support the operations of the Association


